The BAR is a monopoly upon the courts whereas the judge, clerk, prosecutor/plaintiff attorney and defendant attorney and sometimes the Bailiff are ALL members of the BAR. So, who is control, the courts or the BAR?

Since almost all legislators are attorneys, who's in control of the legislature, the representatives or the BAR?
