Most of the links listed below are to databases for California or Federal law that are free of charge. A link to a database for doing many free public records searches is also included, as well as two links to databases that can be very useful for checking out the reputation of companies and individuals to determine their reputation.

<http://www.lexisnexis.com/clients/CACourts/> Searchable database of all published California Supreme Court, Court of Appeal and Appellate Division of the Superior Court decisions all the way back to 1850. Searchable by citation, party name and by using terms.

<http://www.courts.ca.gov/opinions.htm> Database of all opinions for the last 120 days. Note that this database will include some unpublished opinions. Only published cases can be cited or relied upon unless they fall under an exception. See California Rule of Court 8.1115.
